ELIGIBILITY: Only legal residents of the states of AL, AZ, CA, CO, FL, GA, KS, MO, NC, NM, NV, OK, TN, TX and UT, 18 years of age or older, may enter. Not open to employees, officers or directors -- or to members of the immediate family or household of any of the foregoing -- SFM, LLC. HOW TO ENTER: To enter: (i) download the Sprouts mobile app, create a free account (or visit our website (www.sprouts.com) to create one) and sign in (ii) "clip" the "Clif Sweepstakes" entry coupon under the "Mobile Coupons" section on your app. You may be given the option to choose to receive promotional messages from the Sponsor; however, your election to do so is optional and will not affect your chances of winning. Each App entry shall be defined as an "**Entry**" and collectively the "**Entries**."

Participants are limited to one (1) Entry per person. Entries found to be in excess of the limit may be disqualified. Any attempt by a person to enter more than the allowed number of Entries may result in disqualification.
