ELIGIBILITY: Sweepstakes open only legal residents of the states of AL, AZ, CA, CO, FL, GA, KS, MD, MO, NC, NM, NV, OK, SC, TN, TX and UT, 18 years of age or older, may enter. Not open to employees, officers or directors -- or to members of the immediate family or household of any of the foregoing -- of Sprouts Farmers Markets, Inc. ("**Sponsor**"), General Mills Sales, Inc. SWEEPSTAKES PERIOD: The Box Tops for Education Sweepstakes (the "**Sweepstakes**") begins on July 25, 2018 at 12:00:00 p.m. Pacific Time ("**PT**"), and ends on August 29, 2018 at 11:59:59 p.m. PT (the "**Sweepstakes Period**"). The Sponsor's database computer is the official time-keeping device for this Sweepstakes. Proof of submission is not proof of receipt.

HOW TO ENTER: To enter the Sweepstakes: (i) download the Sprouts mobile app, create a free account (or visit our website (www.sprouts.com) to create one) and sign in (ii) "clip" the "Box Tops Sweepstakes" entry coupon under the "Mobile Coupons" section on your app. You may be given the option to choose to receive promotional messages from the Sponsor; however, your election to do so is optional and will not affect your chances of winning. Each App entry shall be defined as an "**Entry**" and collectively the "**Entries**."

Each duly completed Web Entry shall be referenced as an "**Entry**" and collectively the "**Entries**". You may be given the option to choose to receive promotional messages from the Sponsor; however, your election to do so is optional and will not affect your chances of winning.

Entries are limited to one (1) Entry per person, per e-mail. Entries found to be in excess of the above-described limits may be disqualified.
