ELIGIBILITY: Only legal residents of the states of AL, AZ, CA, CO, FL, GA, KS, MD, MO, NC, NM, NV, OK, PA, SC, TN, TX and UT, 18 years of age or older, may enter. Not open to employees, officers or directors -- or to members of the immediate family or household of any of the foregoing -- of Sprouts Farmers Markets, Inc. ("Sponsor") or any of their respective parents, subsidiaries, affiliates, or any advertising or promotion agencies involved in this Sweepstakes promotion (collectively, the "Sweepstakes Entities"). **VOID OUTSIDE AL, AZ, CA, CO, FL, GA, KS, MD, MO, NC, NM, NV, OK, PA, SC, TN, TX & UT, AND WHERE PROHIBITED.**

The Sponsor's database computer is the official time-keeping device for this Sweepstakes. Proof of submission is not proof of receipt.

HOW TO ENTER: To enter: (i) download the Sprouts mobile app, create a free account (or visit our website (www.sprouts.com) to create one) and sign in (ii) "clip" the "Guayaki" entry coupon under the "Mobile Coupons" section on your app. You may be given the option to choose to receive promotional messages from the Sponsor; however, your election to do so is optional and will not affect your chances of winning. Each App entry shall be defined as an "**Entry**" and collectively the "**Entries**."

Each duly completed Web Entry shall be referenced as an "**Entry**" and collectively the "**Entries**". You may be given the option to choose to receive promotional messages from the Sponsor; however, your election to do so is optional and will not affect your chances of winning.
