ELIGIBILITY: Only legal residents of the states of AL, AZ, CA, CO, FL, GA, KS, MD, MO, NC, NM, NV, OK, SC, TN, TX and UT, 18 years of age or older, may enter. Not open to employees, officers or directors -- or to members of the immediate family or household of any of the foregoing -- of Sprouts Farmers Markets, Inc. ("Sponsor") or any of their respective parents, subsidiaries, affiliates, or any advertising or promotion agencies involved in this Sweepstakes promotion (collectively, the "Sweepstakes Entities"). **VOID OUTSIDE AL, AZ, CA, CO, FL, GA, KS, MD, MO, NC, NM, NV, OK, SC, TN, TX & UT, AND WHERE PROHIBITED.**

HOW TO ENTER: To enter: download the NEW Sprouts Mobile App using your smart phone. Create an account, which is free. Visit the Mobile Coupon section of the app and clip the Whole Earth & Sea coupon during the Sweepstakes Period, stated above.

Each "clip" completed shall be referenced as an "Entry" and collectively the "Entries".

"Clips" are limited to (1) Entry per person, per e-mail address. Entries found to be in excess of the above-described limits will be disqualified. Any attempt by a person to enter more than the allowed number of Entries will result in disqualification. Use of any macro, bot, script or other automated means to submit Entries is strictly prohibited.

AGREEMENT: By participating in the Sweepstakes, you unconditionally accept and agree to comply with and abide by these Official Rules.
