
SWEEPSTAKES OFFICIAL RULES

For Sprouts Farmers Market's Gobble Up a Giveaway

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

ELIGIBILITY: Only legal residents of the states of AL, AZ, CA, CO, FL, GA, KS, MD, MO, PA, NM, NV, OK, SC, TN, TX and UT, 18 years of age or older, may enter. Not open to employees, officers or directors -- or to members of the immediate family or household of any of the foregoing -- of Sprouts Farmers Markets, Inc. ("Sponsor") or any of their respective parents, subsidiaries, affiliates, or any advertising or promotion agencies involved in this Sweepstakes promotion (collectively, the "Sweepstakes Entities"). **VOID OUTSIDE AL, AZ, CA, CO, FL, GA, KS, MD, MO, PA, NC, NM, NV, OK, SC, TN, TX & UT, AND WHERE PROHIBITED.**

SWEEPSTAKES PERIOD: The Sweepstakes (the "**Sweepstakes**") begins on November 2, 2018 at 12:00:00 p.m. Pacific Time ("**PT**"), and ends on November 10, 2018 at 11:59:59 p.m. PT (the "**Sweepstakes Period**"). The Sponsor's database computer is the official time-keeping device for this Sweepstakes. Proof of submission is not proof of receipt.

HOW TO ENTER: To enter: (i) visit the website <https://www.sprouts.com/GobbleUp> (the "**Sweepstakes Page**") follow instructions to complete the entry process with the information required in the official entry form provided (no purchase necessary).

Each duly completed Web Entry shall be referenced as an "**Entry**" and collectively the "**Entries**". You may be given the option to choose to receive promotional messages from the Sponsor; however, your election to do so is optional and will not affect your chances of winning.

Web Entries are limited to one (1) Entry per person, per e-mail. Entries found to be in excess of the above-described limits may be disqualified. Any attempt by a person to enter more than the allowed number of Entries may result in disqualification. Use of any macro, bot, script or other automated means to submit Entries is strictly prohibited.

AGREEMENT: By participating in the Sweepstakes, you unconditionally accept and agree to comply with and abide by these Official Rules. All Entries must be received by the end of the Sweepstakes Period. Any information submitted by you will be subject to the privacy policy posted at www.sprouts.com (which collectively with the "Sprouts Sweepstakes Page" shall be referred to as the "**Website**").

Each potential winner will be notified by telephone, mail and/or email using the contact information given on the Entry. No liability is assumed for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If a potential winner does not respond within three (3) days after the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner may be disqualified and an alternate winner may be selected. If any potential winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines a prize for any reason prior to award, such potential winner will be disqualified and an alternate winner may be selected.
