To enter: Download the Sprouts Mobile App using your smart phone, or visit www.sprouts.com. Create an account, which is free. Visit the Promo Code section of the app, enter "WELLNESS" (the "Sweepstakes Promo Code") as a Promo Code and press Submit during the Sweepstakes Period, stated above. Upon submitting the Sweepstakes Promo Code, you will be automatically entered into the Sweepstakes. Each submission of the Sweepstakes Promo Code shall be referred to as an "**Entry**", and collectively the "**Entries**". Limit one (1) Entry per person.
