ELIGIBILITY: Only legal residents of the states of AL, AZ, CA, CO, FL, GA, KS, MD, MO, NC, NV, NM, NV, OK, PA, SC, TN, TX, UT and WA 18 years of age or older, may enter. Each "Comment" or "question" is an "Entry" and collectively the "Entries". Entry requires a Facebook account, which is free. Entries are limited one (1) entry per person per registered Facebook account. Entries found to be in excess of this limit may be disqualified. Any attempt by a person to enter more than the allowed number of Entries may result in disqualification. Use of any macro, bot, script or other automated means to submit Entries is strictly prohibited. By participating in the Sweepstakes, you unconditionally accept and agree to comply with and abide by these Official Rules, which shall be final and binding in all respects.
