**SWEEPSTAKES OFFICIAL RULES**  
**For**  
**Sprouts Farmers Market's**  
**Sprouts Groceries for A Year Sweepstakes**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.**

**ELIGIBILITY:** Only legal residents of the states of AL, AZ, CA, CO, FL, GA, KS, MD, MO, NC, NM, NV, OK, PA, SC, TN, TX, UT and WA, 18 years of age or older, may enter. Not open to employees, officers or directors -- or to members of the immediate family or household of any of the foregoing -- of Sprouts Farmers Markets, Inc. ("Sponsor") or any of its parents, subsidiaries, affiliates, or any advertising or promotion agencies involved in this Sweepstakes promotion (collectively, the "Sweepstakes Entities"). You must have (or create) a Sprouts online account to enter and must remain an account holder as of the scheduled drawing date (12/7/2020) for a chance to win. Accounts are totally free. **VOID OUTSIDE AL, AZ, CA, CO, FL, GA, KS, MD, MO, NC, NM, NV, OK, PA, SC, TN, TX, UT & WA, AND WHERE PROHIBITED.**

**SWEEPSTAKES PERIOD:** The Sweepstakes (the "Sweepstakes") begins on Tuesday, September 1<sup>st</sup>, 2020 at 12:00:01 a.m. Mountain Time ("MT"), and ends on Monday, November 30<sup>th</sup>, 2020 at 11:59:59 p.m. MT (the "Sweepstakes Period"). The Sponsor's database computer is the official time-keeping device for this Sweepstakes. Proof of submission is not proof of receipt.

**HOW TO ENTER:** There are two (2) ways for new Sprouts account holders to enter the Sweepstakes, and two (2) ways for existing Sprouts account holders to enter the Sweepstakes:

**NEW ACCOUNT HOLDERS:**

(1) **TEXT ENTRY (NEW ACCOUNT HOLDERS ONLY):** During the Sweepstakes Period, you can enter by enrolling to receive text information and offers from Sponsor and then following the additional steps below to create your free Sprouts account. To get started, simply text "GETSTARTED" to 50392. You will be sent a one-time reply asking you to confirm your enrollment to receive text information and offers from Sponsor. Upon Sponsor's receipt of your confirmation, you will be automatically sent a message that contains a link directly to the Sprouts.com/signup webpage where you will be prompted to create a Sprouts account. You then must select the "SIGN UP NOW" button and create a Sprouts account. Once the account is created, you will then be sent an email that includes the Sweepstakes entry form which you must fill out and submit in order to complete your entry into the Sweepstakes. After enrollment, you may opt-out of receiving text messages from Sponsor at any time by sending a reply text message with the word "STOP". Text messaging from Sprouts is designed to work with most of the U.S. major wireless carriers in the United States, but Sponsor makes no guarantee that any particular wireless service provider will participate, and the mobile phone that is used must be capable of sending and receiving text messages. Check with your carrier for details. Entrants should check their phone's features to see if they have that capability. Wireless service providers may charge entrants for each text message, including any error message that is sent and received in connection with the Sweepstakes, based on the applicable wireless service pricing plan. **Message and data rates may apply.** Entrants should consult their wireless service provider's pricing plan for details. Entry by consenting to receive text messages from Sprouts will not improve your chance of winning. You are responsible for all applicable fees and taxes associated with submitting or receiving text messages. Sponsor in its sole discretion may add or delete a cellular carrier at any time, without notice. Proof of sending a message is not considered proof of delivery to or receipt by Sponsor of such message.

(2) **WEBSITE VISIT ENTRY (NEW ACCOUNT HOLDERS ONLY):** You may visit Sprouts.com/signup to create a free Sprouts account. You must select the "SIGN UP NOW" button and create a Sprouts account. Once the account is created, you will then be sent an email that includes the Sweepstakes entry form which you must fill out and submit in order to complete your entry into the Sweepstakes.

**EXISTING ACCOUNT HOLDERS:**

(1) **EMAIL ENTRY (EXISTING ACCOUNT HOLDERS ONLY)**: If you already have a free Sprouts account, and have not opted-out of receiving Sprouts marketing communications, you will be sent an email on or about September 1, 2020, that includes the Sweepstakes entry form which you must fill out and submit order to enter the Sweepstakes. After the initial email on September 1, 2020, the Sweepstakes entry form email may be resent periodically to account holders who have not yet entered the Sweepstakes (and who do not opt-out from receiving Sprouts marketing communications) during the duration of the Sweepstakes Period.

(2) **MAIL-IN ENTRY (EXISTING ACCOUNT HOLDERS ONLY)**: Any existing account holder also may enter by doing the following: hand-print on a plain 3"x 5" piece of paper, your name, email address, address, age, and daytime/evening phone numbers, and the word GETSTARTED, and mail your completed entry in an envelope with sufficient postage affixed to: Sprouts Farmers Market Groceries for A Year Sweepstakes, Attn: Kinsey Baumann, 5455 E High Street, Suite 111, Phoenix, AZ 85054. Each postal entry must be mailed separately, postmarked during the Sweepstakes Period, and received by December 3, 2020.

Limit one (1) entry per person, regardless of method of entry. All entries in excess of this limit will be deemed void. Any attempt by a person to enter more than the allowed number of entries may result in disqualification. No automated entry devices, bots and/or other programs and/or software are permitted for entry. No mechanically reproduced, altered, forged, or facsimile entries will be accepted. Winners will be drawn from the database of eligible active account holders as of the drawing date (12/7/2020), and will be contacted based on information in the account, so you must remain an account holder until that date to have a chance to win. All entries become the sole property of Sponsor and will not be returned. Sponsor is not responsible for lost, late, illegible, incomplete, invalid, unintelligible, misdirected, technically corrupted or garbled entries, which will be disqualified, or for problems of any kind, whether mechanical, human or electronic.

Sponsor is not responsible for any change of mailing address and/or telephone number of participants. In the event of a dispute over the identity of a text entrant in the Sweepstakes, entry will be deemed completed by the authorized account holder of the mobile telephone number provided at the time of participation. "Authorized account holder" is defined as the natural person who is assigned to a mobile telephone number by an Internet access provider, online service provider, wireless carrier, or other organization (e.g. business, educational institution, etc.) that is responsible for assigning the mobile telephone number. The potential winner may be required to provide Sponsor with proof that he/she is the authorized account holder of the mobile telephone account associated with the winning entry. If a dispute cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible.

**AGREEMENT:** By participating in the Sweepstakes, you unconditionally accept and agree to comply with and abide by these Official Rules. All Entries must be received by the end of the Sweepstakes Period. Any information submitted by you will be subject to the privacy policy posted at <http://www.sprouts.com/privacy> (which collectively with the "Sprouts Sweepstakes Page" shall be referred to as the "**Website**").

**WINNER SELECTION AND NOTIFICATION:** Ten winners will be randomly selected, on or about Monday, December 7<sup>th</sup>, 2020, from among the eligible account holders who submitted a valid entry and are still account holders as of the drawing date. The potential winners will be notified by telephone, mail and/or email using the contact information listed in their respective Sprouts accounts. No liability is assumed for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If a potential winner does not respond within three (3) days after the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner may be disqualified and an alternate winner may be selected. If any potential winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines a prize for any reason prior to award, such potential winner will be disqualified and an alternate winner may be selected.

**PRIZE/ODDS:** Ten (10) Grand Prizes (the "Prize") are available, each Prize will consist of the following:

\$5,000 in Sprouts Gift Cards. Estimated retail value of each Prize: \$5,000.00.

A substitute of comparable or greater value may be awarded if any prize listed becomes unavailable for any reason. Allow 3 weeks after validation for arrangement for delivery of prize.

or to annoy, abuse, threaten or harass any other person, may be disqualified, and Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law.

Sponsor reserves the right to modify, extend, suspend, or terminate the Sweepstakes, in whole or in part, if it determines, in its sole discretion, that the Sweepstakes is technically impaired or corrupted or that fraud or technical problems, failures or malfunctions or other unintended circumstances have impaired the integrity, administration, security, proper play and/or feasibility of the Sweepstakes as contemplated herein. If the Sweepstakes is terminated before the designated end date, Sponsor will (if possible) select winner(s) in a random drawing from all eligible, non-suspect Entries unaffected by the problem. Inclusion in such drawing shall be each entrant's sole and exclusive remedy in such circumstances.

Only the type and quantity of prizes described in these Official Rules will be awarded. If, for any reason, more bona fide winners come forward seeking to claim prizes in excess of the number of each type of prize set forth in these Official Rules, the winners, or remaining winners, as the case may be, of the advertised number of prizes available in the prize category in question may be selected in a random drawing from among all persons making purportedly valid claims for such prize(s). Inclusion in such drawing shall be each entrant's sole and exclusive remedy in such circumstances.
