NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

ELIGIBILITY: Only legal residents of the states of AL, AZ, CA, CO, FL, GA, KS, MD, MO, NC, NM, NV, OK, PA, SC, TN, TX, UT and WA, 18 years of age or older, may enter. Not open to employees, officers or directors—or to members of the immediate family or household of any of the foregoing—of Sprouts Farmers Markets, Inc. (“Sponsor”) or any of its parents, subsidiaries, affiliates, or any advertising or promotion agencies involved in this giveaway promotion (collectively, the “Giveaway Entities”). You must have (or create) a Sprouts online account to enter and must remain an account holder as of the scheduled drawing date (5/5/2021) for a chance to win. Accounts are totally free. **VOID OUTSIDE AL, AZ, CA, CO, FL, GA, KS, MD, MO, NC, NM, NV, OK, PA, SC, TN, TX, UT & WA, AND WHERE PROHIBITED.**

GIVEAWAY PERIOD: The Giveaway (the “Giveaway”) begins on Tuesday, April 6th, 2021 at 12:00:01 a.m. Mountain Time (“MT”), and ends on Wednesday, April 28th, 2021 at 11:59:59 p.m. MT (the “Giveaway Period”). The Sponsor’s database computer is the official time-keeping device for this Giveaway. Proof of submission is not proof of receipt.

HOW TO ENTER: There is one (1) way for new Sprouts account holders to enter the Sweepstakes, and two (2) ways for existing Sprouts account holders to enter the Sweepstakes:

NEW ACCOUNT HOLDERS:

(1) **WEBSITE VISIT ENTRY (NEW ACCOUNT HOLDERS ONLY):** You may visit sprouts.com/signup to create a free Sprouts account. You must select the "SIGN UP NOW" button and create a Sprouts account. Once the account is created, you will then be sent an email that includes the Giveaway entry form which you must fill out and submit in order to complete your entry into the Giveaway.

EXISTING ACCOUNT HOLDERS:

(1) **EMAIL ENTRY (EXISTING ACCOUNT HOLDERS ONLY):** If you already have a free Sprouts account and have not opted-out of receiving Sprouts marketing communications, you will be sent an email on or about April 6, 2021, that includes the Giveaway entry form which you must fill out and submit in order to enter the Giveaway. After the initial email on April 6, 2021, the Giveaway entry form email may be resent periodically to account holders who have not yet entered the Giveaway (and who do not optout from receiving Sprouts marketing communications) during the duration of the Giveaway Period.

Each postal entry must be mailed separately, postmarked during the Giveaway Period, and received by April 28, 2021.

Limit one (1) entry per person, regardless of method of entry. All entries in excess of this limit will be deemed void. Any attempt by a person to enter more than the allowed number of entries may result in disqualification. No automated entry devices, bots and/or other programs and/or software are permitted for entry. No mechanically reproduced, altered, forged, or facsimile entries will be accepted. Winners will be drawn from the database of eligible active account holders as of the drawing date (5/5/2021) and will be contacted based on information in the account, so you must remain an account holder until that date to have a chance to win. All entries become the sole property of Sponsor and will not be returned. Sponsor is not responsible for lost, late, illegible, incomplete, invalid, unintelligible, misdirected, technically corrupted or garbled entries, which will be disqualified, or for problems of any kind, whether mechanical, human or electronic.

Sponsor is not responsible for any change of mailing address and/or telephone number of participants. In the event of a dispute over the identity of a text entrant in the Giveaway, entry will be deemed completed by the authorized account holder of the mobile telephone number provided at the time of participation. "Authorized account holder" is defined as the natural person who is assigned to a mobile telephone number by an Internet access provider, online service provider, wireless carrier, or other organization (e.g. business, educational institution, etc.) that is responsible for assigning the mobile telephone number. WINNER SELECTION AND NOTIFICATION: Five winners will be randomly selected, on or about Monday, May 5th, 2021, from among the eligible account holders who submitted a valid entry and are still account holders as of the drawing date. The potential winners will be notified by telephone, mail and/or email using the contact information listed in their respective Sprouts accounts. No liability is assumed for any winner notification that is lost, intercepted or not received by a potential winner for any reason.
