

## SWEEPSTAKES OFFICIAL RULES

### For Sprouts Farmers Market's

### Philadelphia-Roosevelt Mall 2024 Grand Opening Gift Card Giveaway Sweepstakes

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

**ELIGIBILITY:** Only legal residents of the State of PA, 18 years of age or older, may enter. Not open to employees, officers or directors -- or to members of the immediate family or household of any of the foregoing -- of Sprouts Farmers Market, Inc. ("Sponsor") or any of their respective parents, subsidiaries, affiliates, or any advertising or promotion agencies involved in this Sweepstakes promotion (collectively, the "Sweepstakes Entities"). **VOID OUTSIDE PA AND WHERE PROHIBITED.**

**SWEEPSTAKES PERIOD:** The Sweepstakes (the "Sweepstakes") begins on Friday, **May 3, 2024**, at 12:00:01 am local time and ends Sunday **June 16, 2024**, at 11:59:59pm local time (the "Sweepstakes Period"). The Sponsor's database computer is the official time-keeping device for this Sweepstakes. Proof of submission is not proof of receipt.

**HOW TO ENTER:** To enter, visit the website [www.sprouts.com/roosevelt](http://www.sprouts.com/roosevelt) ("the "Sprouts Sweepstakes Page") and follow email subscription instructions to complete the entry process. You may also be given the option to receive promotional weekly specials and monthly newsletters from the Sponsor, however, your election to do so is optional and will not affect your chances of winning. Entry is available once in the Sweepstakes Period. By participating in the Sweepstakes, you unconditionally accept and agree to comply and abide by these Official Rules and all decisions of the Sponsor, which shall be final and binding in all respects. All entries must be received by the end of Sweepstakes Period. Any information submitted by you will be subject to the privacy policy posted at [www.sprouts.com](http://www.sprouts.com) (which collectively with the "Sprouts Sweepstakes Page" shall be referred to as the "Website"). Limit (1) entry per person, per e-mail address. Entries found to be in excess of this limit will be disqualified. Any attempt by a person to enter more than the allowed number of entries may result in disqualification. Use of any macro, bot, script or other automated means to submit entries is prohibited.

**WINNER SELECTION AND NOTIFICATION:** One (1) winner will be randomly selected among all eligible entries received by the end of the Sweepstakes Period on **June 16, 2024**. The winner will be notified by telephone, mail and/or email using the contact information given on the Entry. No liability is assumed for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If the potential winner does not respond within three (3) days after the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner may be disqualified and an alternate winner may be selected. If any potential winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines a prize for any reason prior to award, such potential winner will be disqualified, and an alternate winner may be selected.

Allow three weeks after validation for arrangement for delivery of prize. Limit one prize per household.

The authorized account holder shall be the natural person to whom the applicable email address has been assigned by the Internet access provider, service provider, or other online organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.
